Amendment to the Nomination blanks and Condition book for Sunland Park 2017-18:

All entrants into the trials of the Shue Fly, West Texas Maturity, West Texas Derby, NM Spring Futurity, West Texas Futurity, and Copper Top Futurity will pay additional fee of \$100 at time of entry into the trials. This cost will be paid to NMRC for them to hair test all horses that qualify for the finals of these races and any additional hair testing as they deem fit. Also, two horses will be on the also eligible list for the finals of each of these races. If there are positives, then these horses will “draw in” the body of the race.
